That in accordance with the provisions of Sections 6.1 General, 6.2 **Annual Servicing** 6.3 Five year of Annex 1 of the Resolution MSC 402(96), our Flag Administration hereby authorizes **OMEGA SRL** of Venezia, Italy (hereinafter referred to as the Service Provider) to carry out the Annual maintenance, thorough examination, operational testing, overhaul and repair of lifeboats, liferaft and rescue boats, launching appliances and release gear and immersion suits fitted on board the above mentioned vessel whilst at CHIOGGIA-VEITALY.

Conditions under which this authorization is granted:

1. The Service Provider shall carry out the maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear in compliance with the requirements for maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear adopted by the International Maritime Organization in the Resolution MSC 402(96) and SOLAS Reg. III/20.11.
2. The Service Provider attests that they comply with the requirements specified in the Directive 6 of our Merchant Marine Notice MMN-20-001.
3. An authorized Surveyor from MACOSNAR CORPORATION will be in attendance during the maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear.
4. The Service Provider must also comply with any additional requirements from MACOSNAR.
5. A Certificate of Inspection shall be issued by the Service Provider and a copy submitted to our Administration upon completion of the maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear.
6. This is a one-time only authorization; it is not transferable and cannot be used to provide a different service on board this or another vessel at another date and time.

This authorization is granted under the authority of the Government of Belize and will be valid only for the above-described service on board MV MIKA.
