RECOGNITION AS AUTHORIZED SERVICE PROVIDER of Lifeboats, Rescue Boats, Launching Appliances and Release Gear

- The audit report of the Netherlands Shipping Inspectorate, ref. 690676, of 8 October 2024;

Considering:

The requirements of:

- Solas '74, as amended, Regulations I/7 -I/8, Chapter III Regulation III/ 20.11
- IMO circular MSC.402(96) and MSC.404(96);
- The Netherlands Ships Decree 2004, as amended Articles 14 and 40;
- Regulation Recognised Organisations, Ships Act of 31-01-2003, no. HBJZ/SCH/2002-2744;

Declares:

That the service provider Marinspect Safety & Rigging B.V., at their premises in Rotterdam, The Netherlands, has been recognized for the service and inspection of Lifeboats, (fast) rescue boats, Launching Appliances and Release Gear, which are intended for use on board vessels to which the Netherland's Merchant Shipping Act is applicable.

Conditions :

- The Service provider is in the possession of a valid certified quality system.
- The service provider is recognized by EU and NSI contracted RO's.
- The certification of the qualified personnel remain valid and only those Lifeboats, Rescue boats, Launching appliances and Release Gear, are inspected and serviced, the make and type of which the service engineers are certificated for.
- The service provider shall maintain up to date manufacturers documentation and instructions in relation to all equipment being inspected and serviced.
- The service provider shall maintain up to date information in relation to the required constant education and training of the service engineers employed.
- The qualified personnel are employed by **Marinspect Safety & Rigging B.V.** and actually perform the inspections and services.
- In case of changes within the company which influence the work authorised by The Netherlands Shipping Inspectorate, the company shall inform the Netherlands Shipping Inspectorate.

The validity of this approval commences on **17 October 2024** and remains in force until **17 October 2029**, provided that the above-mentioned conditions are met.
