This is to confirm that according to the documentation that was provided by the abovementioned company, it fulfils the requirements set in IMO Resolution MSC.402 (96) "REQUIREMENTS FOR MAINTENANCE, THOROUGH EXAMINATION, OPERATIONAL TESTING, OVERHAUL AND REPAIR OF LIFEBOATS AND RESCUE BOATS, LAUNCHING APPLIANCES AND RELEASE GEAR" which are used when the relevant provisions of SOLAS Chapter III, Regulation 20 are applied, thus it is accepted/recognized by this Administration as a "Service Provider" for lifeboats, launching appliances and on-load release gear further to the review of the submitted material.

It shall be noted that this approval letter is only valid if the National Agency of Maritime Affairs (ANAM) holds upto-date information of the company, such as ISO Accreditation, documentation regarding service engineer qualifications, etc. and as long as company's compliance with the international requirements remains active.

In addition, the Service Provider shall maintain valid manufacturers' authorization certificate for all equipment to be inspected and serviced while its personnel shall hold at all times valid Authorization Certificates issued by the Approved Service Provider or by the equipment manufacturer which sets the level of qualification the scope of the certification related to the make and type of equipment.

It is to be noted that the Service Provider is authorized to perform maintenance, thorough examination, operational testing, overhaul and repair <u>solely</u> to types/models of equipment for which it holds approvals/authorizations from the manufacturer.

At any time, this Administration may require additional information related to the company for its re-approval while ANAM maintains the right to withdraw the approval at any time in case that is it considers that the company no longer meets the approval requirements.
