2. Service engineers shall have valid Qualification Certificates issued by the equipment manufacturer or by the Approved Service Provider to whom this Authorization Document was issued. The Qualification Certificate must define the service engineer's level of qualification and the scope of the certification (e.g., makes and types of equipment).
3. The service provider must possess and shall maintain valid certification issued by the equipment manufacturer verifying that the service provider is certified to perform maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear that is to be inspected and/or serviced or, a valid Approved Service Supplier Certificate issued by a class society recognized by the Liberian Administration verifying that the service provider is certified for the equipment that is to be inspected and/or serviced.

A copy of this Document shall be attached to each report of maintenance, thorough examination, operational testing, overhaul and repair of lifeboats, rescue boats, launching appliances and on-load release gear carried out on Liberian flagged ships. A copy of the Qualification Certificate for the service engineer(s) who inspected and/or serviced the equipment shall also be attached to the report.

A copy of this Document and the applicable manufacturer's authorization shall be provided to the shipowner and the vessel's class society prior to carrying out services on a Liberian flagged ship.
