## **TERMS AND CONDITIONS**

- (5) The registered company shall keep a copy of the service report submitted to this Society and applicant for at least 5 years.
- (6) The registered company shall notify this society immediately of any alterations of the condition at the time of the approval, including changes of staff and of any entries on this certificate.

### **B. Confidentiality**

### **C. Scope and Limitation**
